CALL TO ORDER

President Kolosh called the Meeting to order at 8:02 p.m.

## COMMITTEE REPORTS

**Fire Department Promotions** – No public comment.

Fire Chief Habecker was proud to promote two people from the Thornton Fire Department. This began a while ago when the department started a restructuring. The goal was better call management and better overall control over operations.

Art Schweitzer is being promoted to captain. Art started with the Thornton Fire Department in the mid-90s as a cadet. He's worked as the fire inspector; and for about the last year, he has been working with the training program. Art is a certified fire officer one with the office of the State Fire Marshall, which involves a lot of training.

Glenn Schlessler has been with the Village of Thornton Fire Department for about five years. He was promoted to Lieutenant about two years ago. He has taken over the paramedic program. He is an EMS officer; and has taken over training. He also schedules paramedics for the ambulance.

Glenn is a certified fire officer one; but he just finished his certified fire officer two program.

Fire Chief Habecker presented the Captain badges to Fire Captain Art Schweitzer and Fire Captain Glenn Schlessler, who each had his respective wife pin the badge in place.

On behalf of the Board, President Kolosh thanked Art and Glenn for their hard work and dedication.

Motion by Trustee Kaye, seconded by Trustee Hudson, to approve the promotions of Art Schweitzer and Glenn Schlessler to Captains, as presented.

## TREASURER'S REPORT

**April 2015 Financial Report** – No public comment.

Treasurer Frye stated the April 2015 report is a preliminary report. The overall cash position of the Village is \$2,770,137.95. The General fund has a cash position of \$1,695,172.82. Currently, the General fund is showing an excess of revenues over expenditures of \$424,789. The position of the water fund has already been discussed at Committee. It's up to the Board whether it wants to vote to accept this report or use it for informational purposes until the final is available. Attorney Dillner recommended the Board wait for the final report.

## ATTORNEY'S REPORT

**587-589 N. Williams Street Variance** – No public comment.

Attorney Dillner reported there is an ordinance before the Board regarding a variance at 587-589 North Williams. If there are no questions, a motion would be in order to pass the ordinance with the modifications discussed in Committee.

Motion by Trustee Ehlers, seconded by Trustee Kaye, to approve the Ordinance for the 587-589 North Williams Street variance with the modifications as discussed; specifically, adding Restriction 14, which would be no outside storage of vehicles.

**Village Sticker Ordinance** – No public comment.

Attorney Dillner reported this ordinance adjusts the price of vehicle stickers in the Village of Thornton. The Board passed the changes at the last meeting, and the ordinance implementing the changes is before the Board for approval.

Trustee Atkinson asked what is Permit Section 9-1-2b. Attorney Dillner responded this is an ordinance that allows the parking of commercial vehicles in a driveway.

Motion by Trustee Kaye, seconded by Trustee Ehlers, to approve the Village Sticker ordinance as modified.

PRESIDENT’S REPORT

President Kolosh reported Public Works Superintendent Oberman hired a new full-time employee. He also thanked Superintendent Oberman for all the time he put into this hiring process. Public Works is now at full staff.

President Kolosh thanked Fire Chief Habecker for getting approval for Thornton’s Hazardous Mitigation Plan. It was approved through FEMA. This makes Thornton eligible for hazardous mitigation assistance grants through September of 2019.

The Village of Thornton received a really nice letter from the Village of Oak Forest for the hard work and professionalism of Thornton’s ESDA members. He thanked Janet Carlson, and asked her to pass along his thanks to the rest of the team.

This Friday is the first annual Memorial Day Breakfast the Village will be providing for all Thornton veterans. President Kolosh invited all trustees and department heads to also attend the breakfast. It’s going to be at Jimbooo’s at 9:30 a.m.

The Annual Memorial Day Parade will be on Monday, May 25. Homer Dillard has spent a number of hours coordinating the parade; and President Kolosh invited everyone to come out and celebrate our veterans. The Parade kicks off at 2:00 p.m.; ending with a special ceremony in front of the Village Hall, and hot dogs at the Fire Department. Line up for the parade is between 1:00 and 2:00 p.m. at the Methodist Church.

Lastly, President Kolosh reminded the trustees the SSMMA dinner meeting is Thursday, May 28 at the Olympia Fields Country Club. Trustees should let Clerk Pisarzewski know if they are planning to attend.
